

**DOCUMENT OF CONSENT TO THE TREATMENT OF PERSONAL DATA IN**  
**ACCORDANCE WITH THE GENERAL DATA PROTECTION ACT (LGPD)**

By means of this document of consent to the treatment of Personal Data, I \_\_\_\_\_, registered with the CPF \_\_\_\_\_, holder of the Identification Card \_\_\_\_\_, resident and domiciled at \_\_\_\_\_, hereinafter called **OWNER**, declare that I have been duly informed in a clear manner of the treatment of Personal Data by the **GREENTECH SOLUTION PLATFORM**, which belongs to **FOODTECH GLOBAL SA**, hereinafter called **CONTROLLER**.

This Document was drawn up strictly in conformity with the General Data Protection Act (Law 13709/18) and other laws that are applicable to the matter, in order to record the free, informed and unmistakable statement by which the **OWNER** expressly agrees to the treatment of his Personal Data, for the specific purpose set out below.

***AUTHORIZATION***

The **OWNER** expressly and knowingly, free of any doubts, consents and agrees that the **GREENTECH SOLUTION PLATFORM**, which belongs to **FOODTECH GLOBAL SA**, registered with the NIF A83499764, based in the city of Madrid, Spain, at Calle Henri Dunant, 15-17 (C.P. 28036), e-mail [controller@greentechsolution.digital](mailto:controller@greentechsolution.digital), herein represented by its CEO Martín Cortes Área, (Sole Administrator), makes decisions on the treatment of his Personal Data and also the data on the company where he works and that he represents, and also treats such data,

concerning operations which include information collection, production, receipt, classification, use, access, reproduction, transmission, distribution, processing, filing, storage, elimination, assessment or control, modification, communication, transfer, diffusion, or extraction, as stipulated in article 5 subitem X, of the Brazilian Law 13709/18, to be able to participate in the registration of the company for the selection process, for validation, certification and approval purposes regarding the technical capacity, as well as the supply of agricultural inputs, machines and equipment, in connection with agricultural and related projects.

### ***PERSONAL DATA***

The **CONTROLLER** is authorised to make decisions on the treatment and to treat the following personal data of the **OWNER**:

- Full name; full company name; date of birth; full home and business address; powers of attorney; image of the Marriage Certificate or Declaration of Common-Law Marriage; personal and business e-mail addresses; landline, mobile, business telephone and WhatsApp numbers; number and image of the Identification Card; number and image of the Passport; number and image of the Roll of Individuals (CPF); number and image of the Driving License; number and image of the National Roll of Legal Entities (CNPJ); pictures; videos; bank, branch and account numbers; verbal and written information on the technical-mechanical aspects of the agricultural equipment and machine undergoing the selection process; verbal and written communication between the parties hereto.

Furthermore, the **CONTROLLER** is authorised to make decisions and to treat the data entered by the **OWNER**, in order to enable his registration in the selection process, as undertaken by the **CONTROLLER**, submitted them to the validation, certification and approval phases as to the qualification and supply of his agricultural inputs, equipment and machinery, to be used in the Green Imperative Project.

## ***PURPOSE OF THE TREATMENT***

In accordance with article 8, §4, of the Brazilian law no. 13709/18, this document has a particular purpose, so the data will be used specifically for:

- Registry;
- Initial technical diagnosis for validation of agricultural inputs, equipment and machinery;
- Preparation and application of technical-scientific and practical tests, to check the actual feasibility and suitability of using the agricultural equipment and machinery, as required by the Green Imperative Project;
- Preparation of reports and technical opinions;
- Enabling the Controller to identify and contact the Owner for business relationship purposes;
- Enabling the Controller to enter into commercial contracts with the OWNER;
- Enabling the Controller to structure, test, promote and advertise the agricultural equipment and machinery of the OWNER;
- Enabling the Controller to use such data in Market Research;
- Enabling the Controller to use such data to disseminate other projects/events;
- Enabling the Controller to use such data in the preparation of informative/advertising catalogues;
- Enabling the Controller to use such data in its Communication pieces;
- Enabling the Controller to use such data to write reports and issue the agricultural inputs, equipment and machinery.
- Enabling the Controller to use such data to make out Invoices and similar financial documents;
- Enabling the Controller to use such data to maintain an agricultural inputs, equipment and machinery database, to facilitate the contact for future event/project invitations.

## ***DATA SHARING***

The Controller is expressly authorised to share the Personal Data of the **Owner** with other data treatment agents, if necessary, for the purposes set out herein, observing the principles and guarantees established by the General Data Protection Act.

### ***DATA SECURITY***

The **Controller** is responsible for the maintenance of security, technical and administrative measures to protect the Personal Data from unauthorised access and any accidental or illegal destruction, loss, modification, communication or any other kind of inadequate or unlawful treatment.

As stipulated in article 48, of the Brazilian Law no. 13709/18, the Controller will inform the Owner and the Nacional Data Protection Authority (ANPD) of the occurrence of any security incident which may cause relevant risk or damage to the Owner.

### ***END OF THE DATA TREATMENT***

The Controller can keep and treat the Personal Data of the Owner for as long as those are pertinent to the achievement of the purposes set out herein. Furthermore, the anonymised Personal Data, which cannot be associated with the individual, can be kept for an unlimited time.

Therefore, the Owner can request by e-mail or correspondence to the Controller, at any time, that his non-anonymised Personal Data be **deleted**, being aware that, from that point on, it will be impossible for the Controller to proceed with the selection process, and the respective validation, certification and approval for the supply of agricultural inputs, machinery and equipment by the Owner.

### ***OWNER'S RIGHTS***

The owner is entitled to receive from the Controller, with reference to the data treated by it, at any time and on request: I - confirmation of existence of treatment; II - access to the data; III - correction of incomplete, inaccurate or outdated data; IV - anonymization, blocking or elimination of data that are unnecessary, excessive or treated out of conformity with the Brazilian Law no. 13709; V - portability of the data to another service or product provider, on express request and respecting any trade and industrial secrets, as per the controlling body's regulation; V - portability of the data to another service or product provider, on express request, as per the Brazilian authority's regulation, respecting any trade and industrial secrets; VI - elimination of personal data treated with the owner's consent, except for the events set forth in art. 16 of the Brazilian Law no. 13709; VII - information from the public and private entities with which the controller shared data; VIII - information on the possibility of not giving consent and on the consequences of such a denial; IX - consent revocation, as per § 5, of art. 8, of the Brazilian Law no. 13709/18.

### ***CONSENT REVOCATION RIGHTS***

This document may be revoked at the request of the OWNER, at any time, by e-mail or correspondence sent to the CONTROLLER; in this event the selection activities and processes to be undertaken by the **FOODTECH GLOBAL SA**, may be hindered, as far as our relationship is concerned.
